Verification Agreement

Objectives

Verification Process

The verification was conducted using a risk-based approach, with attention directed to the areas most likely to influence the accuracy and completeness of the reported GHG emissions. This included a review of UIS's information systems, monitoring procedures, and reporting framework, as well as an assessment of the controls in place to ensure data quality and consistency in emission calculations. Supporting evidence was examined on a sample basis to validate the reported activity data, and the application of verification criteria was evaluated for appropriateness and consistency. Based on this approach, sufficient and reliable evidence was obtained to provide a reasonable level of assurance that the reported GHG emissions for the defined period are free from material misstatement and fairly presented.

Verification Conclusion

The GHG emissions inventory of Union Iron & Steel Company L.L.C. (UIS) for the reporting period 1 January 2024 – 31 December 2024 has been verified to a reasonable level of assurance.

According to GIQ-CIS's assessment, the systems and processes used for data

management and reporting were found to be robust, with information presented at a level of quality and completeness that does not indicate any material misstatement against the verification criteria.

This verification statement should therefore be read and understood in the context of the overall GHG assertion made by Union Iron & Steel Company L.L.C. (UIS).
